The undersigned HEREBY ASSUMES FULL RESPONSIBILITY FOR AND RISK OF BODILY INJURY, DEATH OR PROPERTY DAMAGE due to the negligence of releasees or otherwise while competing, officiating, observing, or working for or for any purpose participating in the event. I hereby state that I am in proper physical condition to participate in this event and am aware that participation could in some circumstances, result in physical injury. I further agree to indemnify Releasees, from any claims or damages arising out of or in consequence of the participation or attendance by me in this event.
